

# Statistical Profile of Logan Correctional Center as of 6/30/2021

# Introduction


Logan Correctional Center is located in Lincoln, Illinois, about a two hour and forty-five-minute drive south of Chicago and a 30-minute drive north of Springfield. Logan was repurposed in March 2013 as a multiple security level female facility, which also operates the female intake Reception and Classification center for the Illinois Department of Corrections (IDOC). Logan is now one of only two female correctional centers amongst the 27 IDOC parent facilities.<sup>1</sup>

The following graphs illustrate the demographic and legal characteristics of the people incarcerated at Logan Correctional Center (n = 945), using the population incarcerated at IDOC's other prisons as a comparison group (n = 26,354). The figures reported herein are based upon IDOC's Prison Population Data Set for June 30, 2021(n = 27,299) which is accessible to the public on the <u>IDOC website</u>. Definitions of terms and methodology can be found <u>here</u>.

IDOC defines "Parent Institution" as, "the institution to which satellite facilities such as Adult Transition Centers, Substance Abuse Treatment Centers, Impact Incarceration Programs, Women & Children Programs, work camps, mental health units, and minimum and medium security units are assigned" (note from IDOC's Research and Planning Unit attached to cell J6 in the June 2021 Prison Stock data set).


<sup>&</sup>lt;sup>1</sup> Please note that JHA determines an incarcerated person's location using the "Parent Institution" variable contained within IDOC's population data sets. The parent institution is where an incarcerated person's "Master File" is held. The parent institution listed for most people will match where they were incarcerated as of the date of the applicable data set. For Logan Correctional Center, the parent institution should reflect the location of all people included in the IDOC Population Data Set for June 30, 2021.

# Demographic Characteristics of People Incarcerated at Logan Correctional Center Versus Other IDOC Prisons




Age of Incarcerated People\* as of June 30, 2021


#### Estimated Age at Custody\*

#### Estimated Age at Release\*, \*\*





\*\* 49 incarcerated persons are not included in the Logan figures for the graph above. 43 of these people are serving a court-imposed life sentence, and the remaining 6 do not have a Projected MSR date listed in the applicable IDOC data set for reasons unknown; 2,136 incarcerated persons are not included in the 'Other IDOC' comparison group. Of these people, 1,470 are serving a court-imposed life sentence, 156 are civilly committed to IDOC as Sexually Dangerous Persons, and the remaining 510 do not have a Projected MSR date listed in the applicable IDOC data set for reasons unknown.








#### Length of Court-Imposed Prison Sentence for Holding Offense\*, \*\*







# Effectively Eligible by Law to Receive Earned Sentence Credits for Holding








#### Time Served for Holding Offense as of June 30, 2021\*, \*\*

\*\* Time served for holding offense determined by calculating time elapsed between a person's Custody Date and the date of the applicable data set.




#### Estimated Time Until Release (based on Projected MSR date) \*, \*\*, \*\*\*

\*\* 6 incarcerated persons are not included in the Logan figures for the graph above because they do not have a Projected MSR date listed in the applicable IDOC data set for reasons unknown; 666 incarcerated persons are not included in the 'Other IDOC' comparison group. Of these people, 156 are civilly committed to IDOC as Sexually Dangerous Persons and the remaining 510 do not have a Projected MSR date listed in the applicable IDOC data set for reasons unknown.

\*\*\* Incarcerated persons included in the Negative Value category are mostly MSR or Parole violators who are being held past their Projected MSR Date. The amount of time until release for most incarcerated persons included in the graph above may change if "good time" is either awarded or revoked from them, and other factors.
